6 – ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

Use personal protective equipment. Avoid breathing vapours, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Beware of vapours accumulation to explosive concentrations. Vapours can accumulate in low areas.

6.2 Environmental precautions

Prevent further leakage or spillage if safe to do so. Do not let product enter drains.

6.3 Methods and materials for containment and cleaning up

Small Spill: Absorb with an inert material and put the spilled material in an appropriate waste disposal.

Large Spill: Combustible material. Poisonous liquid. Keep away from heat. Keep away from sources of ignition. Stop leak if without risk. Do not get water inside container. Do not touch spilled material. Use water spray to reduce vapors. Prevent entry into sewers, basements or confined areas; dike if needed. Call for assistance on disposal.

7 – HANDLING AND STORAGE

Precautions:

Keep away from heat. Keep away from sources of ignition. Ground all equipment containing material. Do not ingest. Do not breathe gas/fumes/ vapor/spray. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes.

Storage:

Store in cool place. Keep container in a cool, well-ventilated area. Keep container tightly closed and



sealed until ready for use. Avoid all possible sources of ignition (spark or flame).
